New Business

- Redraw process as per the team organization policy, each year the league teams are rearranged to achieve balance. First step is to gather information from captains, then arrange for any evaluations needed. Some offers will be made to players whose stats clearly illustrate dominance at their level. An email with dates for sign up, return of offers, etc. will go out to whole club. Only league evaluations will be made at this time (Feb 24/25?). Will be done by pros rather than other club members. New teams will be posted by March 6, then current captains are asked to conduct a meeting with new team by March 12 to elect captains, verify other duties if possible e.g. RR coordinator, confirm team duties volunteers.
- Re-evaluation process -Players will have the opportunity to sign up for re-evaluations. However, not all sign-ups will lead to an evaluation. Co-Presidents will consider statistical information and input from coaches before inviting players to be evaluated. Successful season performers may also be considered for moving up. Evaluation will occur over one or two days, depending on volume, with similar level players participating in match scenarios. Chris Langdon will conduct evaluations. The process will involve warm-ups followed by 20-minute match scenarios.
- **Court usage March** how many of current blocks should be maintained through March? Round robin? League play time? How many courts? Please send info to Karalee, otherwise group time slots will be released for general play.
- **Team photos** to be organized by teams. If you want your team photo displayed on the TV program, please send to Bal.
